- 1.04/20 **Apologies for absence**: none received
- 2.04/20 **Declarations of interest**: no changes from those on file.
- 3.04/20 **Minutes approved:** 27<sup>th</sup> February 2020 and 26<sup>th</sup> March 2020.
- 4.04/20 **Matters arising:** none
- 5.04/20 **Actions from previous meetings:** CS & RL have exchanged emails with Therfield Parish Council but not met yet. The village greens were cut at the end of March.

#### 6.04/20 Finance:

- i. An updated budget had been circulated. CSw is awaiting advice from the accountants regarding what help we may be eligible for.
- ii. Brian Racher grant CS to lead and consider costs for car park works and/or bin rationalisation.

#### 7.04/20 Stakeholder Management

- i. Tenant rents CC to contact JJ and Heath Sports Club.
- ii. Rugby and Cricket BH and CS to resume communications with these clubs about agreements
- iii. Archery and Runners licences JK to initiate communications about licences

#### 8.04/20 Heath and Greens Maintenance

- i. Communication received about closing the car parks due to COVID-19. RL had asked police for advice and in the light of that, it was decided not to shut the car parks unless specifically told do by the government. It was felt that it would create a problem on local roads. CSw and CS to generate communications to put out for the Easter weekend reminding people about current government guidelines and the byelaws, especially no cycing on site. RL to remind police that cycling is not allowed on site.
- ii. Rubbish bins agreed to accept quote from the Golf Club to empty bins from 1<sup>st</sup> May on a monthly basis. **BH** to start thinking about rationalising the bins and work out a strategy.
